SLP(c) No. 11311/2014

None appears for respondent nos. 1-3, 6-9, 11 and 12 despite due service.

SLP(c) No. 11312/2014

None appears for respondent nos. 1-4 despite due service.

weeks' time. Notice be issued thereafter.

S.L.P.(C) No. 9723 of 2014

It is submitted that service of notice is complete on both the respondents but no one has filed Vakalatnama/Appearance on their behalf so far.

S.L.P.(C) Nos. 11303 of 2014

It is submitted that Service of notice is complete on respondent Nos. 1 and 2 but no one has filed Vakalatnama/appearance on their behalf so far.

It is further submitted that counsel for the petitioner has not taken any fresh step for effecting service of notice on the unserved respondent Nos. 3 and 4.

S.L.P.(C) Nos. 11304 of 2014
