Rest of the matters

I.A.No. 128859 of 2018 and 113591 of 2018 in SLP (C) No. 16669 of 2017 - applications for impleadment/intervention are allowed.

Heard the learned counsel appearing on both sides.

The Expert Committee which has been constituted to look into the disputes/objections regarding the questions and answers, shall complete the task positively within one month from today. We also direct the Police Recruitment Board and the govt. to send all those candidates who have otherwise been cleared on account of the examination by the Expert Committee, for training within another

four weeks, subject to the candidates completing codal formalities. We further make it clear that on account of the exercise undertaken by the Expert Committee, the candidates who have already been selected shall not be disturbed.

The Committee constituted for verification of documents of caste/domicile/freedom fighters etc. shall complete the process positively within four weeks and the candidates shall be sent for training within another four weeks, subject to completion of codal formalities. However, the candidates who have already been selected, shall not be disturbed.

It is submitted that as far as 189 candidates coming under the whitener/blade category, the Recruitment Board has entrusted the task of identification and selection to another agency. We fail to understand as to what was the requirement for another agency, since the principle is the same and it is only a question of identifying the candidates who have secured the higher marks.

Be that as it may, we direct the Police Recruitment Board to complete the process and the Recruitment Board and the Government shall send 189 candidates for training positively within six weeks from today, subject to the candidates cooperating for the completion of the codal formalities.
