O R D E R

All matters

Ld. counsel for the petitioner is granted two weeks' time as final opportunity to take fresh steps and file fresh particulars in respect of unserved respondents.

Ld. Counsel for the petitioner is granted four weeks' time as final opportunity to take appropriate steps in respect of deceased respondent nos.1 and 3 in SLP(C) No. 8809/2022.

Respondent nos.1 and 4 (i) in SLP(C) No. 11150/2020 and respondent nos. 1 to 3 in SLP(C) No. 11964/2022 are granted four weeks' time for filing counter affidavit.

Opportunity to respondent nos. 1 and 5 in SLP(C) No. 11990/2020 and respondent nos. 8 to 12 in SLP(C) No. 12285/2020 to file counter affidavit has already been declined.

Ld. Counsels appearing for the respondents to whom last opportunity to file counter affidavit has already been granted, their further opportunity to file counter affidavit stands declined.
