It is submitted that Mr. Ajit Sharma, Advocate has on 01.09.2015 filed the Contempt Petition above-mentioned for willful disobedience of this Court's Orders dated 24.04.2015 & 15.05.2015 and the same has been registered as Contempt Petition (C) No. 622 of 2015.

Mehrotra and Ms. Binu Tamata, Advocates have entered appearance on behalf of respondent Nos. 2, 3 & 4. Mr. Abhijit Sengupta, Advocate has entered appearance on behalf of respondent Nos. 5 to 29. No one has entered appearance on behalf of respondent No. 1 though served with notice.

Service of Rule Nisi is complete.

It is lastly submitted that Contempt Petition in the Writ Petition above-mentioned was mentioned before the Hon'ble Court on 11.09.2015, when the Court was pleased to pass the following Order:

"List the matter on 14th September, 2015."
