Heard learned counsel for the parties.

We find that the number of Child Welfare Committees and Juvenile Justice Boards have not been constituted in all the Districts in the following States and Union Territories.

By the next date of hearing, the aforesaid States and Union Territories will furnish up to date information along with an affidavit as to whether in all the Districts the Child Welfare Committees and Juvenile Justice Boards have been constituted. In the alternative, the Child Welfare Committees and Juvenile Justice Boards will be constituted in the Districts in which they have not been so far constituted.
