Similar forms with more and better particulars can easily be prepared and the information obtained online which can then be monitored more effectively.

Learned Additional Solicitor General says that he will look into the matter and advise the Ministry accordingly and ensure that a necessary programme is prepared.

It is further stated by learned Additional Solicitor General that the information that has already been received is being collated. This will take about a month or so for collation. The information as on 31st March, 2016 should be placed before us a few days before the next date of hearing.
