O R D E R

SLP(C) Nos.18285, 18288, 18358, 18357, 18230, 18238, 18237, 18236, 18235, 18305, 18308, 18363, 18309, 18354, 18353, 18352, 18286, 19128, 19126, 19078, 19050, 19038, 19529, 23571, 23560, 23566, 24676, 21993, 22048 & 19842/2017

Await the return of service of notice already issued to all the respondents.

SLP(C) Nos.18284, 18297, 18368, 19044, 19035 and 18362/2017

Service is complete. The respondents shall be at liberty to file the counter affidavit within a period of four weeks.

SLP(C) No.18229/2017

Ld.counsel for the petitioner has not filed the spare copy, hence notice could not be issued. However, Ld.counsel submits that sole respondent is on caveat. Registry to verify, if so, issue formal notice and the sole respondent may file the counter affidavit within four weeks.

SLP(C) Nos.18356, 18272, 19043, 19042/2017

The served respondents shall be at liberty to file the counter affidavit within a period of four weeks.

Await the return of service of notice already issued to the unserved respondents.

SLP(C) No.18360/2017

The respondent Nos.1,5 & 8 shall be at liberty to file the counter affidavit within a period of four weeks.

Ld.counsel for the above respondents informed that the respondent Nos.12 & 13 is the same and one person and this respondent and respondent No.2 have died. Ld.counsel for the petitioner to verify and if so, take appropriate steps to bring on record the lrs. Of the abovesaid respondents within four weeks.

SLP(C) No.18310/2017

The respondent Nos.1-14 & 16 shall be at liberty to file the counter affidavit within a period of four weeks.

The respondent No.15 is reported to be dead. Id.counsel for the petitioner shall within a period of four weeks file an application for substitution to bring on record the Lrs. Of the said respondent.

SLP(C) No.18355/2017

The respondent Nos.1, 2 and 5 shall be at liberty to file the counter affidavit within a period of four weeks.

Ld.counsel for the respondent No.4 has already filed the vakalatnama which is defective. Ld.counsel shall rectify the defects whatever have been found in the said vakalatnama within four weeks.

Await the return of service of notice already issued to the respondent No.3.

SLP(C) No.20752/2017

The respondent No.1(caveator) shall be at liberty to file the counter affidavit within a period of four weeks.

Ld.counsel for the petitioner has failed to file the spare copy for issuance of notice to the unserved respondent No.2, in spite of order dated 3.07.2017 of the Hon'ble Court. Therefore, the matter shall be processed for listing before the Hon'ble Judge in Chambers for further directions.

SLP(C) No.19037/2017
