OFFICE REPORT

I. SLP © NO. 8704-06, 8709-10,8712-13 OF 2014, 3302 & 3300 AND 20072 OF 2015

The matters above mentioned were listed before the Hon'ble Court on 24.11.2015 with an office report dated 23.11.2015 , when the Court was pleased to pass the following Order:

*“List along with C.A. 5826 OF 2011 and connected matters.”*

Accordingly, the matters have been tagged with CA No. 5826 of 2011.
