**OFFICE REPORT**

The matters above-mentioned have been filed by Mr. Ankur S. Kulkarni, Advocate, on behalf of the Petitioner against the Final Judgment and Order dated 3<sup>rd</sup> December, 2015 of the High Court of Karnataka at Bangaluru in Writ Petition Nos. 31191 of 2008 and 15432 of 2010. Hence, the defects pointed out by the Registry may be ignored. Copy of the letter dated 25<sup>th</sup> May, 2016 has already been placed at Page No. 470 of the Paper Book.
