O R D E R

1. The present petition has been filed by the petitioner-wife seeking transfer of HMA No.1014/2021 under Section 13 (1)(i-a) & (i-b) of the Hindu Marriage Act, 1955 filed by the respondent-husband titled "*Ravi v. Madhuri*" pending before the Principal Judge, Family Court (North-East) at Karkardooma Court, Delhi to the Court of competent jurisdiction at District Agra, Uttar Pradesh.

2. Heard learned counsel for the parties and perused the material placed on record.

3. Having regard to the averments and considering the grounds on which transfer has been prayed for, HMA No.1014/2021 titled "*Ravi v. Madhuri*" pending before the Principal Judge, Family Court (North-East) at Karkardooma Court, Delhi is ordered to be transferred to the District Judge, Agra, Uttar Pradesh to be assigned to a competent Court for hearing and disposal in accordance with law.

4. Records shall be sent by Court where the proceedings are pending to the transferee Court promptly.

5. The transfer petition is, accordingly, allowed and disposed of.

6. On receipt of the case records, the transferee Court shall explore the possibility of a mediated settlement between the parties before proceeding with the merits of the matters.
