These special leave petitions require an answer to the third question noticed in paragraph '3' of the judgment in "*Union of India v. M. V. Mohanan Nair*"¹, which reads as under: -

1 (2020) 5 SCC 421

"Whether the respondents are entitled to stepping up of their grade pay to be on a par with grade pay of their juniors who were getting the higher grade pay on account of implementation of MACP Scheme?"

Learned counsel for the parties will file written submissions on the said question not exceeding two pages.
