Learned Additional Solicitor General has placed before us a letter dated 8<sup>th</sup> October, 2015 sent by the Under Secretary to the Government of India, Ministry of Road Transport and Highways. Paragraphs 3 and 4 of the letter reads as follows:

- "3. Accordingly, a draft note for CCA was put up before Hon'ble Minister, RTH & Shipping. Hon'ble Minister has enquired about the details of any precedent of such kind. Ministry of Urban Development (MoUD) informed that they do not have the precedent wherein rent free residential accommodation has been provided to the Chairman of a Court appointed Committee.
- 4. Since there is no precedent in this regard, the Ministry of Road Transport & Highways is not in a position to approach Cabinet Committee on Accommodation for allotment of Government residential accommodation to the Chairperson of Road Safety Committee."

Under the circumstances, regrettably, nothing further can be done in the matter.

Accordingly, this writ petition stands disposed of.
