Mr. F.S. Nariman, learned Senior Counsel appearing for the State of Karnataka prays that hearing in the application may be deferred till 12th October, 2012, as he is expecting some orders by the Chairperson of the Cauvery River Authority (CRA) on the review petition filed by the State of Karnataka. He, however, apprehends that our order dated 28th September, 2012, passed in

I.A. No.5 of 2012 in O.S. NO.3 of 2002, may come in the way of the Chairperson in taking a decision on the review petition.
