Interlocutory Application No. 5 of 2012

Mr. S. Wasim A. Qadri, learned counsel for the Union Of India, submits that the notification has been issued by the Government of India under Section 6 of the Inter-State Water Disputes Act, 1956 publishing the decision of the Cauvery Water Disputes Tribunal dated February 5, 2007 in the Official Gazette. We accept his statement.

We are informed that water is being released by Karnataka in compliance of the order dated February 7, 2013.

In view of above, nothing further remains for decision in this Interlocutory Application.

Interlocutory Application No. 5 of 2012 stands disposed of accordingly.
