Mr. R.S. Suri, Ld. ASG appearing for the petitioners has informed this Court that the petitioners have recorded their consent to implement the judgment impugned in the instant petitions and wants some time to carry out calculations and payment to each

employee pursuant thereto.

The order impugned in the instant proceedings was passed by the High Court on 04.11.2019, almost two years back. We consider it appropriate to observe that let the payment be made in compliance of the judgment dated 04.11.2019 to the recipients/employees before Diwali break and we hope and trust that no further application will be filed even by the employees regarding non-compliance of our Order.
