From the impugned order, we find that the High Court has declined to entertain the PIL on the ground that clearance/approval has been granted on 17<sup>th</sup> September, 2019. The High Court did not notice that the challenge was itself to the approval granted on 17<sup>th</sup> September, 2019. As the said challenge has not been gone into on merits, we set aside the impugned order dated 18<sup>th</sup> April, 2023 and restore Public Interest Litigation No.92 of 2019, to the file of the High Court.

The Civil Appeal is disposed of accordingly.
