The application has been registered as Crmiminal Miscellaneous Petition NO. 7812-7814 of 2015. Copy of same is being circulated herewith for kind perusal of the Hon'ble Court.

It is lastly submitted that the Hon'ble Court vide its order dated 09.01.2015 while directing issue of notice to the unserved respondents has not passed the order for effecting dasti service. However, Ms. Ruchi Kohli Counsel for the Petitioner in Special Leave Petition(Crl.) No 324-326 of 2015 has filed affidavit of dasti service with proof of service in respect of all respondents except on Respondent No.10 in Special Leave Petition(Crl.) No. 325 of 2015 on whose behalf
