Detailed inquiry will also be carried out in respect of the allegations made

in paras 7 and 13(IV) of the Writ Petition. The Managing Director of

HUDCO Mr. Rana is made responsible for ensuring that all documents,

papers and information required by the Central Vigilance Commission is

given to the Central Vigilance Commission forthwith on their asking for the same. The Central Vigilance Commission to submit its report within four months from today.
