Four weeks time as last chance is given  
to the respondent No.4 to file the counter  
affidavit.

List the matters again on 18.10.2016."

SLP (C) No. 20999/2015

It is submitted that Mr. Shankar Divate, Advocate has on 23.09.2016 filed affidavit of dasti service along with proof in respect of Respondent Nos. 4 and 5 stating therein that Respondent Nos. 4 and 5 duly served.

Service of show cause notice is complete.

SLP(C) No.21135/2015
