Leave granted in SLP (C) No.18565 of 2014; SLP (C) No.30629 of 2014; SLP (C) No.14111 of 2015; SLP (C) No.19200 of 2017 and SLP (C) No.23945 of 2017.

The appeals filed by the Union of India and others are dismissed. The appeal filed by the assessee is disposed accordingly in terms of the signed reportable judgment.
