UPON hearing the counsel the Court made the following O R D E R

- 1. Leave granted.
- 2. The appeals are partly allowed and the impugned order is set aside partially in terms of the signed order which is placed on the file.

3. The operative part of the signed order is read as under:-

"25. Accordingly, the appeals are partly allowed and the impugned order is set aside partially. We hold that the appellants would be entitled to $2/3^{rd}$ share, and the respondent no. would be entitled to 1/3rd share of subject property. For the sake of avoiding any confusion, also make we respondents no. 5 to 7 before this Court are heirs of Ram Prakash, legal who Petitioner No. 3 before the High Court and also belong to the lineage of Ochchey Lal. As such, it is clarified that the familial lineage of Ochchey Lal, in its entirety, shall be entitled to the above-stated $2/3^{rd}$ share in the property.

26. Further, the amount of Rs. 2,00,000/(now the amount of the Fixed Deposit Receipt
(FDR) is Rs. 2,14,162/-) deposited by the
appellants is directed to be released in their
favour, alongwith accrued interest if any.."
