UPON hearing the counsel the Court made the following O R D E R  $\,$ 

## SLP(C) NO.24838/2014

Service is complete in respect of respondent nos. 1,4 and 5 but none has entered appearance.

Respondent nos. 2 and 3 have not filed counter affidavit inspite of last opportunity provided. Further opportunity is therefore declined.

#### SLP(C) NO.24837/2014

Service is complete in respect of respondent nos. 3 and 5 but none has entered appearance.

Respondent no.4 has not filed counter affidavit inspite of opportunity given to him.
