Pursuant to the Order quoted above, Counsel for the Respondents have not filed any document supporting/opposing the statement made by the Counsel for the Petitioner that these Transfer Petitions have become infructuous. Counsel for the Petitioner has not taken fresh steps for service upon R-1 in T.P.(C) No. 1691 of 2014 but he has filed spare copy in form of paper books on 14th July, 2016 and same is defective.
