Four weeks time is given to the respondent No. 1 to file the

counter affidavit.

As per postal tracking report notice issued to respondent Nos. 10 to 12 could not be served and returned back undelivered. Hence, learned counsel for the appellant shall within a period of two weeks file the fresh particulars of the said respondents and he shall also take fresh steps for the service of notice to them within the same period
