**O R D E R**  
 Issue notice.

The respondent-National Testing Agency is directed to declare the result of the NEET (UG) 2021 and the petitioners who will be declared successful are permitted to appear in the counselling in the General Category against the centrally administered 15% All India Quota Seats and 85% State administered seats, on par with Indian Citizens to pursue MBBS/BDS courses and other undergraduate courses in approved/recognised Medical/Dental & other Colleges/Institutes covered by the National Eligibility cum Entrance Test-Undergraduate, 2021.

It is made clear that the aforesaid interim relief is limited to the academic year 2021-2022 only.
