UPON hearing the counsel, the Court made the following

O R D E R

Both matters

Common respondent nos. 7,23 and 34 in SLP(C) No.3133/2021 and SLP(C) NO.3137/2021, common respondent nos. 6,7,23,34,51 and 52 in SLP(C) No.3138/2021 and SLP(C) No.3141/2021 , respondent nos. 43 and 44 in SLP(C) No.3139/2021, respondent nos. 3 and 4 in SLP(C) No.3140/2021 remain unserved and despite grant of final opportunity to the respective petitioners, fresh steps alongwith fresh particulars for service upon them have not been taken/filed, accordingly, Registry to process the matters for listing before the Hon'ble Judge in Chambers for necessary directions.
