The Transfer Petition above mentioned was listed before the Hon'ble Court on 24th August, 2015 when the Court was pleased to pass the following Order:-

"Issue notice returnable in four weeks.
T.P. (C) Nos.911-924/2014 and T.P. (C) No.885/2015
be also listed along with the present Petition."

Accordingly, matters were tagged and notice was issued to the all Respondents through concerned High Court.

It is submitted that Certificate of Services in respect of all the respondents is still awaited from High Court.

TRANSFER PETITION (CIVIL) NO. 885 OF 2015

The Transfer Petition above mentioned was listed before the Hon'ble Court on 08th June 2015 when the Court was pleased to pass the following Order:-

"Issue notice.

Tag with T.P. (C) Nos. 911-924 of 2014 and SLP (C) Nos. 9921-9923 of 2014.

There shall be stay of further proceedings in W.P. (C) No. 21525 of 2015 (GM-RES), pending before the High Court of Karnataka, during the pendency of the petition."

Accordingly, the instant matter was tagged with T.P.(C) 911-24 of 2014 and SLP(C) 9921-23 of 2014 notice were issued to all the Respondents on 20.07.2015 through concerned High Court.

It is submitted that Mr. Nikhil Majithia, Advocate has filed Vakalatnama and Memo of appearance on behalf of Respondent No. 5 and also filed Counter Affidavit on his behalf after serving its copy on other side. Copies of the Counter Affidavit is being circulated herewith for kind perusal of the Hon'ble Court.

It is further submitted that Certificate of service in respect of Respondent no.1 to 4 is still awaited from the High Court.

Service of notice is not complete on all respondents except Respondent No. 5.

TRANSFER PETITION (CIVIL) NO. 911 - 24 OF 2014

The matters above-mentioned were listed before the Hon'ble Court on 25th August, 2014, when the Court was pleased to pass the following Order:-

"Mr. Neeraj Kishan Kaul, learned ASG states that the tender process is likely to be completed within two months and prays for an adjournment on this count. Permission granted. List on 3rd November, 2014.

Till the next date, interim order to continue."

Accordingly, copy of the said Order was sent to the concerned High Courts.

It is submitted that Mr. Vipin Kumar Jai, Advocate has on 17th September, 2014 filed Vakalatnama and Memo of appearance on behalf of Respondent No. 1 in T. P. Nos. 911, 914-917, 920-924 of 2014.

It is further submitted that Mr. Vipin Kumar Jai, Advocate has on 18.09.2014 filed application for direction in T.P. No. 911 of 2014 after serving its copy on the other side which has been registered as I.A. No. 29 of 2014. Copy of the same has been tagged with the paper books.

It is also submitted that Mr. Vipin Kumar Jai, Advocate has on 24.09.2014 filed another fresh application for direction in T.P. No. 911 of 2014 after serving its copy on the other side which has been registered as I.A. No. 30. Copy of the same has been tagged with the paper books.

The applications above-mentioned were listed before the Hon'ble Court on 17th October 2014, when the Court was pleased to pass the following Order:-

"Re-notify on 3rd November, 2014."

It is lastly submitted that Mr. Vipin Kumar Jai, Advocate has on 29.10.2014 filed applications for vacating stay in T. P. Nos. 911, 914-917, 920-924 of 2014 after serving its copy on the other side which has been registered as I.A. Nos. 31-40 of 2014. Copy of the same is tagged with the main Paper Books.

It is submitted that High Court of Andhra Pradesh at Hyderabad, High Court of Madras at Chennai have sent the status report of W.P. No. 21183 of 2013 and WP Nos. 16877-16878, 15679-15680 of 2013 that they are still pending.
