UPON hearing the counsel through Video Conference, the Court made the following

**O R D E R**

**SLP (C) No. 15178/2021**

Ld. Counsel for respondent Nos.1 to 3, 8 to 11 have failed to file the counter affidavit within the period stipulated under the rules. Service of notice is complete on respondent No. 7 but no one has entered appearance on his behalf.

Two weeks time, as last chance is granted to the petitioner, for furnishing fresh particulars in respect of unserved respondent Nos.4 to 6.
