**UPON hearing the counsel the court made the following  
O R D E R**

1. Mr. P.S. Patwalia, learned Senior Counsel and Mr. Ashok K. Parija, learned Advocate General appearing for the State Government submit that 29 petitions have been filed assailing the common judgment and order dated 12<sup>th</sup> April, 2023 passed by the High Court. While six of them (i.e. SLP(Civil) Nos.18205,17956, 17482, 17635, 17705 and 19299/2023) have been listed before this Bench, four of them (i.e. SLP(Civil) Nos.17393,16825,16949 and 16945/2023) were listed before a Coordinate Bench. The remaining have yet to be listed and are in the pipeline. It is requested that all the matters be taken up together before one Bench.
