O R D E R

SLP(C) No. 21856/2022

Respondent Nos. 1 and 2 have already filed the counter affidavit.

Four weeks time is granted to respondent No.6 to file the counter affidavit.

Two weeks time is granted to Ld. Counsel for petitioner to file spare copies for issuance of notice in respect of respondent Nos. 3.1 and 3.2.

Despite service of notice on respondent Nos.5 and 7 to 9, there is no appearance on their behalf.

Application for substitution filed in respect of deceased respondent No.4 is defective. Two weeks time is granted to cure the defects.
