UPON hearing the counsel the Court made the following
O R D E R

1. An affidavit has been filed by Shiv Das Meena, presently working as Chief Secretary, Government of Tamil Nadu.
2. From the perusal of the affidavit it cannot be said that there is compliance with the directions issued by this Court vide order dated 18.04.2023.
3. Various difficulties have been expressed by the learned Attorney General for India for implementation of the judgment of this Court in the case of Bimlesh Tanwar and the first judgment of the Madras High Court. However, the said difficulties were already expressed by the learned Additional Advocate General, when we passed the order on 18.04.2023. We had rejected his submissions in that regard.
4. Faced with these situation, learned Attorney General for India seeks some time to work out the time table so that the law laid down in Bimlesh Tanwar and the first judgment of the Madras High Court can be implemented in its true spirit.
5. We, therefore, grant two weeks' time to the State Government to come out with some positive suggestions so as to give effect to the aforesaid judgments of this Court and the Madras High Court.
