**SLP(C) NO. 38759/2016**

It is submitted that the counsel for the petitioner has not filed counter-affidavit on behalf of respondent nos.1-7, so far.

It is further submitted that Mr. Ajay talesara, Advocate has on 22.03.2017 filed vakalatnama on behalf of respondent no.23 but no counter-affidavit has been filed, so far.

It is lastly submitted that the counsel for the petitioner has neither taken fresh steps for service on respondent nos.8 to 18, 20, 22, 24, 26-43 and 45-49 nor provided fresh address of respondent no.48, so far.

It is further submitted that counsel for the petitioner has not taken fresh steps for effecting service on unserved respondent Nos. 3-5 & 7-9. Hence notice could not be issued.

**SLP(C) No. 995/2017**
