- 6. The respondent No.2 (accused No.6) shall surrender within three weeks from today.
- 7. It is needless to say that he will be at liberty to file an appropriate application seeking his release on bail, and if any such application is filed, that will be considered by the Trial Court in accordance with law.
- 8. We are clarifying that we have not expressed any opinion on the merits of the case.
