O R D E RSLP(C) No. 18902/2016

Service of notice is complete on respondent Nos. 1, 5 and 11 but no one has entered appearance on their behalf.

Four weeks time is given to the respondent No. 4 to file the counter affidavit.

Fresh steps for the service of notice by usual mode to the respondent Nos. 3,8 to 10, 12 and 14 to 18 shall be taken by the learned counsel for the petitioners within a period of two weeks.

As per postal tracking report notices issued to the Respondent Nos.2 and 13 have been received back with postal remarks "No Such Person" and in respect of Respondent Nos. 6 and 7 notice received back with postal remarks "Incomplete address". Hence, learned counsel for the petitioners shall within a period of four weeks file the fresh particulars of the said respondents and he shall also take fresh steps for the service of notice to them within the same period.
