**S.L.P. (C) NO. 25411/2014**

The matter above-mentioned was mentioned and taken on board on 07.04.2014, when the Hon'ble Court was pleased to pass the following order:

**S.L.P. (C) NO. 24181-182/2014**

It is submitted that there are nine respondents in these matters. Respondent No. 1 is common in both the matters. Mr. P. K. Jain, Advocate has filed vakalatnama & memo of appearance and Counter affidavit on behalf of Respondent No. 1. Copy of the same has already been included in the paper books. Ms. Ruchi Kohli, Advocate has filed vakalatnama & memo of appearance on behalf of Respondent No. 2 & 8 but counter affidavit awaited. Mr. Praveen Swarup, Advocate has filed vakalatnama & memo of appearance on behalf of Respondent No. 3 but counter affidavit awaited. Ms. Pratibha Jain, Advocate has filed vakalatnama & memo of appearance on behalf of Respondent No. 4 and 7 without affixing stamp of Dental College and Hospital but counter affidavit awaited.

Mr. Gaurav Sharma, Advocate has accepted notice on behalf of Respondent Nos. 5 and 9 ( Medical Council of India) but counter affidavit awaited. Counsel for the petitioner has on 12.09.2014 filed affidavit of dasti service in respect of Respondent No. 6 but no one has entered appearance on behalf of him so far.

Service is complete in both the matters.

**S.L.P. (C) NO. 24189-24190/2014**

It is submitted that there are five respondents in these matters. Ms. Ruchi Kohli, Advocate has filed vakalatnama & memo of appearance on behalf of Respondent No. 2 and 5 but counter affidavit awaited. Counsel for the petitioner has on 12.09.2014 filed affidavit of dasti service in respect of Respondent Nos. 1, 3 and 4 but no one has entered appearance on behalf of them so far.

Service is complete.

**S.L.P. (C) NO. 8769-70/2015, 9346, 9457 & 9506 of 2015**

The matters above-mentioned were listed before the Hon'ble Court on 27.03.2015 when the Hon'ble Court was pleased to pass the following order:

**S.L.P. (C) NO. 9346/2015**

It is submitted that there are twenty-four respondents in the matter. Mr. Gaurav Sharma, Advocate has entered appearance on behalf of respondent No. 5 but has not filed counter affidavit. The Counsel for the petitioner has filed affidavit of dasti service with proof after effecting service on respondent No. 1 to 13, 18 & 22. It is also stated in affidavit that respondent Nos. 14 to 17, 19 to 21, 23 and 24 have refused to receive the notice and notice was sent by way of speed post.

**S.L.P. (C) NO. 9457/2015**

It is submitted that there are twenty-two respondents in the matter. The Counsel for the petitioner has filed affidavit of dasti service with proof after effecting service on respondent Nos. 1 to 12. It is also stated in affidavit that respondent Nos. 13 has refused to receive the notice. He has filed an application for deleting the name of respondent Nos. 14 to 22 which is registered as I. A. No. 4. Copy of the same is being circulated herewith.

It is further submitted that counsel for the petitioner has filed application for directions which is registered as I. A. No. 3. Copy of the same is being circulated herewith.

**S.L.P. (C) NO. 9506/2015**

It is submitted that there are nineteen respondents in the matter. The Counsel for the petitioner has filed affidavit of dasti service with proof after effecting service on respondent Nos. 1 to 12. It is also stated in affidavit that respondent Nos. 13 has refused to receive the notice. He has filed an application for deleting the name of respondent Nos. 14 to 19 which is registered as I. A. No. 4. Copy of the same is being circulated herewith.

It is further submitted that counsel for the petitioner has filed application for directions which is registered as I. A. No. 3. Copy of the same is being circulated herewith.

**S.L.P. (C) NO. 8769-70/2015**

It is submitted that there are ten respondents (Common in both the SLPs). Mr. P. K. Jain, Advocate has filed vakalatnama on behalf of Dr. Yogendra Singh Gurjar but has not filed counter affidavit. Counsel for the petitioner has filed affidavit of dasti service in respect of all the respondents but he has not filed proof of dasti service in respect of respondent No. 6 (UGC).

It is submitted that counsel for the petitioner has on 24.04.2015 filed application for permission to file additional documents alongwith document-I. Copy of the same is being circulated herewith.
