**UPON hearing the counsel, the Court made the following
O R D E R**

I.A. NOs.158705, 158385, 158386 and 158708 of 2022

Having heard the learned counsel for the parties, we are inclined to partly modify our order and direct that the appellant shall make payment of current charges for the electricity uploaded/injected into the system by the respondents at the rate of Rs. 3.50 per Unit. The balance amount to be paid in terms of the order passed by the Maharashtra Electricity Regulatory Commission (MERC) dated 03.07.2020, shall be deposited in this Court and converted into interest bearing Fixed Deposit Receipt for a period of 12 months, which would be renewed periodically. The deposit in the court would be made bi-monthly.

It is the case of the appellant that they had made the payment of the dues for the period up to 31.03.2017. The appellant shall file an affidavit along with a chart indicating the total amount of electricity uploaded/injected, and the amount with dates of the payment made to each party.

The applications are disposed of accordingly.

We also give liberty to the appellant to move an application for impleadment of parties, which, as per the decision of the appellate tribunal, should not have been given the benefit of the 2015 Policy.

Re-list in the month of February, 2023.
