SLP (C) NOS. 19139, 19166, 19306, 19548, 18359-18368, 18745, 18547-18566, 19032-19039, 17081, 19904-19924, 21977-21978, 20146, 21857-21863, 22936, 23005, 24920 AND 26867 OF 2016.

The matters were listed before the Hon'ble Court on 14<sup>th</sup> September 2016 with office report dated 12<sup>th</sup> September 2016, when the Court was pleased to pass the following orders:

**“Issue notice in SLP (C) No.24867 of 2016.**

**Time is granted till 26.09.2016 to the petitioner(s) to make the payment at six paise per unit. If the amount is not paid at six paise per unit on or before 26.09.2016, we make it clear that the special leave petitions will not be entertained. The payment will be subject to further orders.**

**Service in all the matters be completed through the Central Agency.**
