O R D E R

The learned counsel appearing for the parties, who are present in the Court, state that all the parties to these appeals have agreed that clause (iv) of paragraph 39 of the impugned judgment be modified by consent by reducing the rate of interest from 12% to 9%.

We accordingly modify clause (iv) of paragraph 39 in the following terms:

"iv) Interest on arrears due to the developers as a consequence of determination of tariff on the basis of above norms to be allowed at the rate of 9% to be compounded on quarterly basis."

No other modification is sought by the parties.

With the above modification, the appeals are disposed of.

The learned counsel appearing for the appellants in Civil Appeal Nos.1376-1385 of 2013 states that the amounts payable in terms of the impugned judgment as modified above shall be paid within a period of six weeks from today. It is ordered accordingly.
