**Civil Appeal No. 6005/2010**

It is submitted that there are Thirteen respondents in the matter. Respondent Nos. 1,4 and 5-8 are represented through Mr. Himinder Lal, Mr. Rakesh Kumar Sharma and Mr. Pradeep Misra, Advocates respectively. Certificate of service in respect of Respondent Nos. 2,7,9 and 11 have been received but no one has entered appearance so far.
