Respondent No. 3 has adopted the counter affidavit filed by respondent no.1.

Respondent No.15 is petitioner no.7 in the connected matter i.e. SLP(C) No. 12430/2024. Hence, service is deemed to be complete on respondent No.15. Today, Ld.
