**OFFICE REPORT**

The matter above mentioned was listed before the Hon'ble Court on 02.05.2016, when the Court was pleased to pass the following order:

"Permission to file special leave petition is granted.  
Application seeking exemption from filing certified copy of the impugned judgment and order is allowed.  
Issue notice.  
In the meanwhile, there shall be stay of operation of the impugned order of the High Court."
