OFFICE REPORT

It is submitted that the above mentioned Special Leave Petition is filed by Mrs. Priya Puri, Advocate on 30.09.2015 against the Judgment and Order dated 27.05.2015 of the High Court of Punjab and Haryana at Chandigarh in FAO No. 4311/2013 (O&M) along with the applications for exemption from filing certified copy of impugned order.

It is further submitted that Counsel for the petitioner has filed two applications for condonation of delay in filing the SLP and refiling the SLP (i) there is a delay of 36 days in filing the SLP (ii) a delay of 71 days in refiling the SLP. There is a total delay of 107 days in filing and refiling the SLP.

It is further submitted that the instant matter is tagged with SLP (C) CC No.741 of 2016 Entitled Punjab

State Power Corporation Ltd. Versus M/s. Sangrur Industrial Corporation Ltd. And Anr. as both are arising out of common order.

It is further submitted that Counsel for the petitioner has not furnished the copies of order dated 23.12.2008, 21.1.2010, 26.7.2010, 17.11.2013, 23.7.2015. In this regard, counsel has given a letter dated 08.1.2016 (letter is enclosed in the paper books at Page No. 87) stating therein that the same are not necessary for the preliminary determination of the present matter and order dated 17.11.2013 is not related and Counsel has requested to register and list the matter at his own risk.

It is further submitted that the counsel for the petitioner has on 18.01.2016 filed an application for additional documents i.e. Award dated 23.12.2008 & copy of claim petition dated 27.05.2002. Copies of the same are being circulated to the Hon'ble Court.

The matter is listed before the Hon'ble Court with this office report.
