Accordingly, show cause notice by Regd. A.D. Post
was issued on 11.02.2011.

Service of show cause notice is incomplete.

It is submitted that Mr. Rajinder Mathur, counsel
for the petitioner has on 29.01.2016 filed an application
for substitution to bring on record LRs. of deceased
Respondent Nos. 4, 5, 6, 8, 9, 10, 12 and 13 along with
applications for condonation of delay in filing
substitution application and setting aside abatement.
There is delay of more than 1844, 2219, 8063 days of the

deceased Respondent Nos. 4, 5 and 10 as counsel has filed a letter dated 01.02.2016 (copy enclosed) stating therein that exact date of death of Respondent Nos. 4, 5 & 10 could not be found out despite making many efforts and he is not aware of any other LR's. of the said deceased respondents. Counsel has requested that the applications may be processed as it is to be avoid un-necessary delay in the matter. There is delay of 1172, 7736, 6311, 5139 and 2889 days of deceased Respondent Nos. 6, 8, 9, 12 and 13. The same are registered as I.A. Nos. 2-4.

The applications in the matter above-mentioned are listed before the Hon'ble Court (In Chamber) with this office report.
