C.A. No. 10448/2014 and 10499/2014

C.A. No. 1376-1385/2013

Respondent Nos.4 to 6 in CA No.1376/2013, respondent Nos.7 to 9, 16, 19, 20, 23 and 30 in CA No.1377/2013, respondent Nos.1, 4 and 10 in CA No.1378/2013, respondent No.4 in CA No.1379/2013, respondent Nos.11 to 13 in CA No.1380/2013, respondent No. 6 in CA No.1381/2013, respondent Nos.1 to 10, and 13 to 15 in CA No.1382/2013, respondent Nos.1, 4 to 6 in CA No.1383/2013, respondent Nos.1, 4, 5 and 6 in CA No.1384/2013 and respondent Nos.1 to 3, 6 and 7 in CA No.1385/2013 are yet to be served.
