## ORDER

Delay condoned.

After hearing learned counsel for the appellant this Court is of the opinion that there is no reason to interfere with the impugned orders.

However, given the propensity of the appellant to contest the liability for such a prolong period and also to file the present appeals, this Court is of the opinion that additional cost has to be imposed. As result, additional Rs. 50,000/- shall be paid in the case of each claimant. Consequently, an additional sum of Rs. 3,50,000/- shall be deposited with the Collector within

six weeks from today. The Collector shall disburse the sum to the concerned claimants and file report of compliance within eight weeks from today.

The civil appeals are dismissed in the above terms.
