Service is complete on respondent Nos.19 & 23 in C.A.
No.11358-11359/2018 but none has entered appearance.

Remaining respondents have been served.

Ld. Counsels appearing for the duly represented
respondents appearing for the first time are granted four
weeks time for filing counter affidavit.

Ld. Counsels who are already appearing for the served
respondents are granted four weeks time as last opportunity
for filing counter affidavit.

Ld. Counsels for the served respondents who were given
last opportunity for filing counter affidavit and have not
filed counter affidavit, their further opportunity stands
declined.
