**OFFICE REPORT**

The Special Leave Petitions above-mentioned have been filed against the Judgment and final Order dated 24<sup>th</sup> February, 2014 of the High Court of Judicature, Andhra Pradesh at Hyderabad in W.P. Nos. 13824 and 8119 of 2013.

The matters were mentioned before the Hon'ble Court on 22<sup>nd</sup> September, 2014, when the Hon'ble Court was pleased to pass the following Order:
