UPON hearing the counsel the Court made the following ORDER

(I.) SLP(C) No. 19952/2024

I.A. No.235708/2024

- The present application has been filed seeking deletion of the names of respondent Nos.67 to 152 from the array of respondents (who were the co-petitioners with the petitioners in the Writ Petition filed by the petitioners).
- 2. Permission as sought for is granted to delete the said respondents at the risk of the petitioners.
- I.A. No.235708/2024 is allowed accordingly. 3.
- 4. Amended cause title be furnished accordingly.
- 5. Let the notices be issued to the remaining respondents, returnable after four weeks.

(II.) Diary No. 33721/2024

- 1. The learned senior counsel, Mr. Patwalia for the petitioners seeks permission to withdraw the present application seeking deletion of the respondents, with liberty to file a proper application.
- 2. Permission as sought for is granted.
- I.A. No.203110/2024 is dismissed as withdrawn. 3.

- 5. Notices be issued in SLP (C) No.23311/2024 after the amended cause title is furnished as per the orders passed in I.A. No.222695/2024 and I.A. No.235888/2024, returnable after four weeks.

(IV.) SLP(C) No. 23310/2024 (SLP (C) Diary No.34005/2024)
