**UPON hearing the counsel the court made the following  
 O R D E R**

1. It is pointed out across the Bar that against the judgment and order dated 10<sup>th</sup> May, 2022 passed by the High Court of Punjab and Haryana at Chandigarh involving a similar issue, Special Leave Petition (Civil) No. 8478 of 2023 (Diary No.34993 of 2022) was filed by the Punjab State Power Corporation Ltd. which has been dismissed by this Court on 24<sup>th</sup> April, 2023. However, it is pointed out that against the same judgment and order dated 10<sup>th</sup> May, 2022 another Special Leave Petition (Civil) No. 9981 of 2023 (Diary No.34990 of 2022) was filed in which notice has been issued on 04<sup>th</sup> May, 2023. Moreover, it is pointed out that in respect of the order dated 24<sup>th</sup> April, 2023, a Review Petition is pending.

2. Therefore, it will be appropriate if SLP (Civil) No. 9981 of 2023

(Diary No.34990 of 2022) is heard along with this group of matters.

3. The Registry is directed to seek appropriate directions from Honb'le the Chief Justice of India in this behalf. If the cases are assigned to this Bench, the same shall be listed on 11<sup>th</sup> January, 2024.
