OFFICE REPORT

It is submitted that the above mentioned Special Leave Petition is filed by Mrs. Priya Puri, Advocate on 16.10.2015 against the Judgment and Order dated 27.05.2015 of the High Court of Punjab and Haryana at Chandigarh in FAO No. 550/2014 (O&M) along with the applications for exemption from filing certified copy of impugned order.

It is further submitted that Counsel for the petitioner has filed two applications for condonation of delay in filing the SLP and refiling the SLP (i) there is a delay of 52 days in filing the SLP (ii) a delay of 59 days in refiling the SLP. There is a total delay of 111 days in filing and refiling the SLP.

It is further submitted that the instant matter is tagged with SLP (C) CC No.741 of 2016 Entitled Punjab

State Power Corporation Ltd. Versus M/s. Sangrur Industrial Corporation Ltd. And Anr. as both are arising out of common order.

It is further submitted that Counsel for the petitioner has not furnished the copies of order dated 1.10.06, 24.7.08, 30.7.2007, 17.11.2013, 23.12.2008, 17.4.13. In this regard, counsel has given a letter dated 12.1.2016 (letter is enclosed in the paper books at Page No. 80) stating therein that the same are not related for adjudication of the case and Counsel has requested to register and list the matter at his own risk.

It is further submitted that the counsel for the petitioner has on 18.01.2016 filed an application for additional documents i.e. order dated 24.07.2008, Award dated 1.10.2006 & copy of claim petition dated 03.09.2008. Copies of the same are being circulated to the Hon'ble Court.

It is further submitted that Mr. Vikash Singh, Advocate has on 15.01.2016 filed a caveat on behalf of Respondent No. 1.

The matter is listed before the Hon'ble Court with this office report.
